In 2023, the IOCC Foundation funded livelihood initiatives in both Syria and Ethiopia, ensuring that vulnerable populations have the tools they need to shape their futures.

After more than a decade of conflict, Syrians face a complex economic crisis, with millions unemployed – especially young adults and women. But new opportunities are arising in jobs once open only to men, and with some training, women and young adults can position themselves for success in the shifting labor market. With funding from the IOCC Foundation, IOCC is providing courses in English language, finance, tech skills, and more. So far, we've helped hundreds of Syrians gain marketable professional skills and grow their earning power.

In Ethiopia, work began on an IOCC Foundation funded project to bring an

irrigation canal and improved irrigation practices in the Amhara region. An initial needs assessment of 145 local households has been completed, and data has been collected to measure progress toward food security goals at the end of the project. With instability and armed conflict in the region, construction has been temporarily halted to prioritize the safety of staff and beneficiaries. Security assessments are currently being conducted, and a mitigation plan will be created to prioritize the construction phase of the canal. When complete, this new irrigation canal will help support 600 households and ultimately more than 3,000 residents, mostly smallholder farmers, stabilize and grow their agricultural productivity, improve nutrition, and raise their standard of living.

As it often does, the IOCC Foundation helps to fund projects that lay the groundwork for opportunities of growth and sustainable change. Thank you, once again, for your commitment and partnership. We continue, as always, to pray for peace, stability, and hope for a brighter future for those in great need.
